ABSTRACT

The study aimed to assess the professional competencies of the academic reference librarians of the Order of Augustinian Recollects (OAR) tertiary institutions in the Philippines. The expected and actual professional competencies were sought to identify training needs. Task analysis method was used to consolidate, summarize and categorize duties and responsibilities according to library functions as indicated in their job descriptions.

Findings revealed that OAR academic reference librarians performed other functions other than reference such as circulation, organization and design of services, reader's advisory, collection development, and user education. New skills and newly acquired set of competencies which are not indicated on their job descriptions were performed by the librarians. OAR academic reference librarians possessed adequate skills, knowledge, abilities and demonstrated a high level of competencies on these areas: technological know-how like the use of emerging technologies or tools; communication skills; skills on dealing with users needs and creating new library services; knowledge and skills in selection, acquisition, and evaluation of reference sources particularly with online and electronic sources; and working with information literacy training program; however, they need some training.

It was recommended that job descriptions should be revisited and modified to determine their usefulness, effectiveness, and responsiveness in these changing times. A training program for reference librarians was designed to enhance actual professional competencies and to provide new skills and knowledge in performing their job so that excellent services will be given to library users.
