#### 1. UN Digital Library (Dag Hammarskjöld Library)

Our products include: bibliographic metadata, Index to Proceedings, Index to Speeches, Voting Records, UNBIS Thesaurus, research guides and frequently asked questions.

#### 2. UN Data

The UN Data is a web-based data service for the global user community. It brings international statistical databases within easy reach of users through a single-entry point. Users can search and download a variety of statistical resources compiled by the United Nations (UN) statistical system and other international agencies. The numerous databases or tables collectively known as "datamarts" contain over 60 million data points and cover a wide range of statistical themes including agriculture, crime, communication, development assistance, education, energy, environment, finance, gender, health, labour market, manufacturing, national accounts, population and migration, science and technology, tourism, transport and trade.

#### 3. govinfo

govinfo is a service of the United States Government Publishing Office (GPO), which is a Federal agency in the legislative branch. govinfo provides free public access to official publications from all three branches of the Federal Government.

In addition to providing an advanced, metadata-powered search experience, govinfo also includes a content management system and a standards-compliant preservation repository. These three components comprise GPO's world-class system for the comprehensive management of electronic information:

- Public access GPO combines modern search technology with extensive metadata creation to ensure the highest quality search experience. Users can easily access documents for free by searching or browsing the mobile-friendly website.
- 2. Content management GPO securely controls digital content throughout its lifecycle to ensure content integrity and authenticity. This includes the application of digital

- signatures to PDF files so users can verify documents have not been altered and are the official versions.
- 3. Digital preservation GPO's ISO 16363 certified Trustworthy Digital Repository ensures content is preserved for future generations despite technical failure, aging of hardware, or technological change.

# 6. Scimago Journal & Country Rank

The SCImago Journal & Country Rank is a publicly available portal that includes the journals and country scientific indicators developed from the information contained in the Scopus® database (Elsevier B.V.). These indicators can be used to assess and analyze scientific domains. Journals can be compared or analysed separately. Country rankings may also be compared or analysed separately. Journals can be grouped by subject area (27 major thematic areas), subject category (313 specific subject categories) or by country. Citation data is drawn from over 34,100 titles from more than 5,000 international publishers and country performance metrics from 239 countries worldwide.

# 9. Central European Journal of International and Security Studies

Central European Journal of International and Security Studies is a quarterly journal that publishes peer-reviewed scholarly articles across the entire field of International Relations and International Security. Since its foundation in 2007, it has been proudly committed to the principle of open access publishing. CEJISS puts an emphasis on the quality and fairness of the peer-review process and openness about its policies. While based in Prague and the Central European region, CEJISS has always had a global outlook.

CEJISS is a pluralist journal. It favours a variety of theories and methods used as well as topics and geographical areas covered. Nonetheless, CEJISS is particularly (but not exclusively) interested in drivers of the contemporary world's change – from geopolitical shifts, nationalist resurgence and regionalisation to environmental and technological changes. Rather than specialising in a particular theme, it prefers to understand the broader impacts and mutual entanglements of these processes. CEJISS has published articles focused on Central and Eastern Europe as well as on other regions and the global international system. It is open to inter-disciplinary, cross-thematic and trans-regional works discussing international aspects of politics and security. CEJISS also welcomes policy-relevant articles. However, please note that all articles must meet the usual research standards (they need to be research articles in the first place).

CEJISS is indexed by Scopus, ProQuest, Ebsco, Google Scholar and other databases. All the manuscripts undergo both editorial screening and double-blind review by external experts in a given topic.
